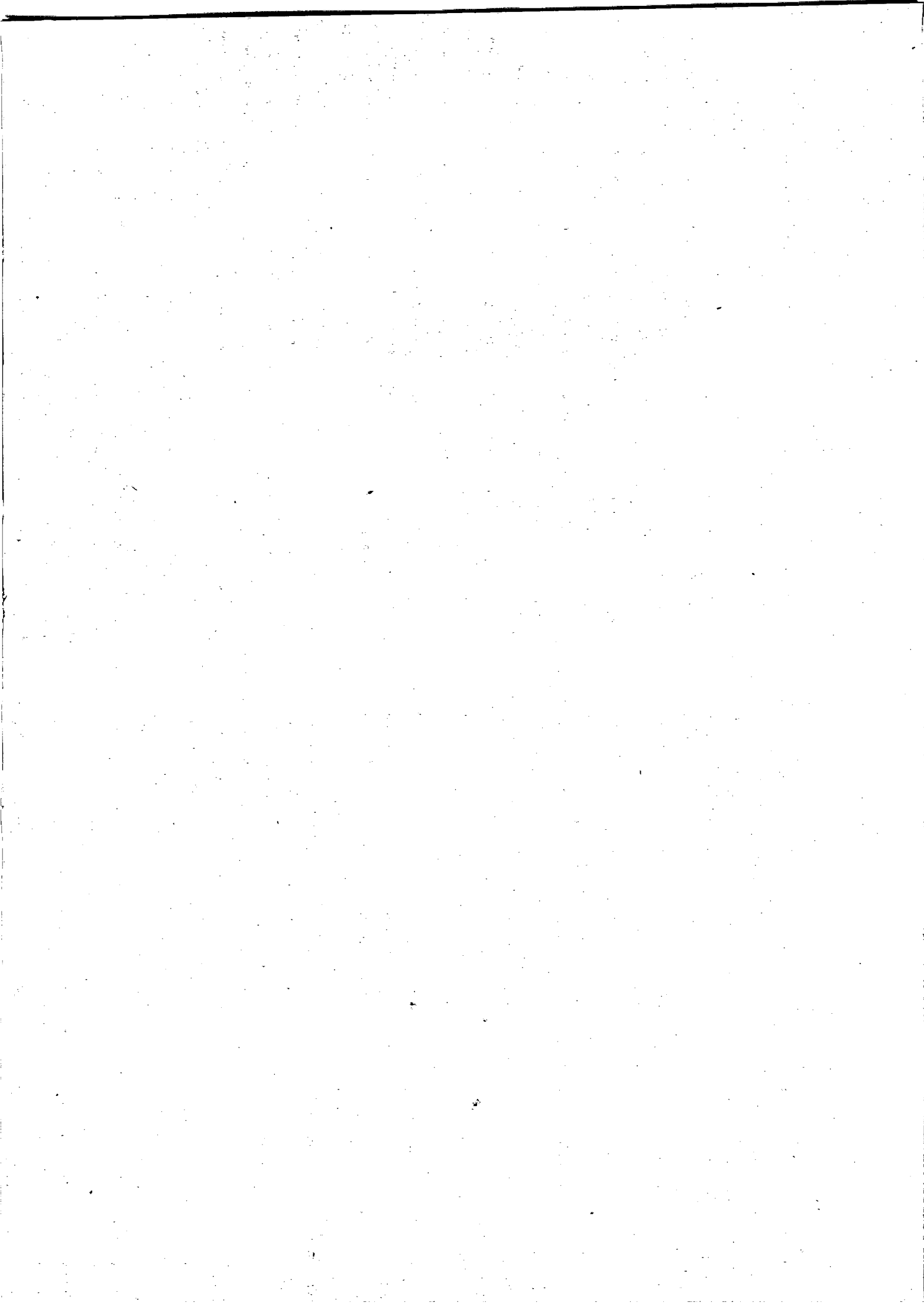

## MADHYA PRADESH PUBLIC SERVICE COMMISSION

### (Limitation of Functions) Regulations, 1957

[Published under Notification No. 3302/1(i), dated the 17th April, 1957]

In exercise of the powers conferred by the proviso to clause (3) of Article 320 of the Constitution of India and in supersession of the Madhya Pradesh Public Service Commission (Limitation of Functions) Regulations, 1953 and the Madhya Bharat Public Service Commission (Limitation of Functions) Regulations, 1953, the Governor of Madhya Pradesh is pleased to make the following Regulations, namely :—

1. These regulations may be called the Madhya Pradesh Public Service Commission (Limitation of Functions) Regulations, 1957.

2. In these regulations—

- (a) “the Commission” means the Public Service Commission, Madhya Pradesh;
- (b) “the Constitution” means the Constitution of India.

3. It shall not be necessary for the Commission to be consulted in regard to—

- (a) the appointment by direct recruitment or by promotion or by transfer, to any of the posts or classes of posts or to any of the services to the extent specified in the Appendix of these Regulations;
- (b) the re-employment within three years of a retired or retrenched Government Servant in a post which he was holding at the time of his retirement or retrenchment, or for duties which he had performed previously in the course of his service of his retirement or retrenchment;
- (\*) (c) the appointment by promotion to any of the post or classes of posts or of any of the services other than that specified in the Appendix to these Regulations or the confirmation on such post to be made on the recommendations of a Departmental promotion Committee or a Departmental Committee set up for consideration of confirmation of officers on the aforesaid post as the case may be where such committee is presided over by the Chairman or member of the Commission.

4. It shall not be necessary for the Commission to be consulted on any of the following matters, namely :—

- (i) the creation and organisation of services and posts and their designation;
- (ii) the classification of services and posts;
- (iii) the general methods of recruitment to a service or post, that is, whether the recruitment should be made by examination, selection or promotion or transfer, or partly by one of these methods and partly by another, and in the latter case, the proportion in which recruitment to any particular service or grade should be made by each method and the relative seniority of candidates recruited by different methods;
- (iv) the determination of the number of vacancies to be filled in a service in any particular year;
- (v) the determination of the cadre of the various services;
- (vi) question whether recruitment for particular posts should be confined to nationals of India or not;
- (vii) the determination of the salary of Government servants on their first appointment and of officiating incumbents of posts;

- (viii) the determination of the initial salary of Government servants recruited by promotion;
- (ix) transfer of Government Servants to Foreign Service; and
- (x) the probation and training of Government servants and the conditions of their confirmation in service.

5. (1) It shall not be necessary for the Commission to be consulted on the suitability of a person for appointment, promotion or transfer to a post the period of which does not exceed six months.

(2) In order cases where appointment, promotion or transfer to a service or post would otherwise require consultation with the Commission, it shall not be necessary to consult the Commission, if owing to an emergency the Commission cannot be consulted without detriment to public service :

Provided that—

- (i) intimation of such appointment promotion or transfer shall be sent to the Commission at the same time, and
- (ii) action to fill up the post in the normal way or to obtain the concurrence of the Commission, as the case may be, shall be initiated as early as possible.

6. (1) It shall not be necessary to consult the Commission in regard to the making of any order in any disciplinary case other than—

- (a) an original order by the State Government imposing any of the penalties specified in rule 10 of the Madhya Pradesh Civil Services (Classification, Control and Appeal) Rules, 1966 (hereinafter referred to as the said Rules);
- (b) an order by the Governor on an appeal against an order imposing any of the penalties specified in the said rules made by a subordinate authority;
- (c) an order by the Governor over-ruling or modifying after consideration of any petition or memorial or otherwise, an order imposing any of the penalties specified in the said rules, made by the Governor or by a subordinate authority;
- (d) an order by the Governor imposing any of the penalties specified in the said rules, in exercise of his powers of review and in modification if an order under which none of the penalties specified in the said rules has been imposed;

(2) It shall not be necessary to consult the Commission—

- (a) where, after completion of the departmental enquiry the Government servant is to be exonerated or no penalty is proposed to be imposed and it is decided to close the case after issuing a simple warning to the Government Servant.
- (b) when the order to be passed is—
  - (i) an order relating to the discharge or reversion of an officer other wise than as a penalty;
  - (ii) an order for the imposition of any paenalty prescribed in any rule or order for failure to pass any test or examination within a specified time;
  - (iii) an order terminating the employment of an officer in accordance with the terms of his contract or employment;
  - (iv) an order relating to the continuation or termination or probation or the discharge of an official serving on probation;

- (v) an order for the compulsory retirement of government servant under the Madhya Pradesh Civil Service (safeguarding of National Security) Rules, 1961;
- (vi) an order for dismissal or removal of Government servant issued in exercise of the powers conferred by proviso (c) to clause (2) of Article 311 of the constitution.

7. It shall not be necessary for the Commission to be consulted :—

- (a) an any claim for payment of costs for defending legal proceedings, referred to in sub-clause (d) of clause (3) of Article 320 of the Constitution, where the claim is admitted in full.
- (b) on any claim for award of an injury pension, or on any question as to the amount of any such award, referred to in sub-clause (e) of clause (3) of Article 320 of the Constitution, where the aforesaid claim or question is in respect of a person appointed by an authority subordinate to the State Government.

8. It shall not be necessary for the Commission to be consulted on any matter relatın to a commissioned officer in any of the Armed Forces, holding a civil post in connection with the affairs of the State.

9. Notwithstanding anything contained in these rugulation, the Governor may direct that the commission shall be consulted in any particular case.
